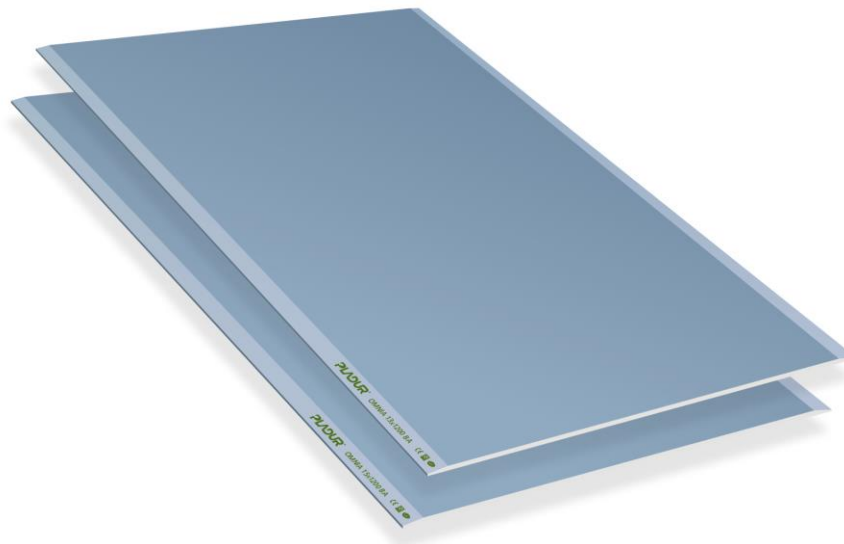

ABOUT THE MANUFACTURER

Pladur Gypsum, S.A.U. is one of the main suppliers of products for drywall systems, offering valuable solutions for partitions, ceilings, wall linings, and external sheathing. Pladur® products are used in both new constructions and renovation projects, providing systems with performance characteristics suitable for all construction sectors, including residential, commercial, hospitality, and healthcare.

PRODUCT DESCRIPTION

Pladur® OMNIA is a range of plasterboards made of a natural gypsum core entrapped between two paper liners. Pladur® OMNIA is designed for multi-purpose applications

Pladur® OMNIA 13 and OMNIA 15 are plasterboards complying with EN 520:2009+A1 Type I, D, F, R, H1 (high surface hardness, impact resistance, load-bearing capacity, fire resistance, and acoustic insulation, even in humid environments). They are blue in colored with 13 mm thickness, 1200 mm width with tapered edges (BA).

Pladur® OMNIA plasterboards are used in Pladur® interior systems where multiple performance requirements are needed, such as wall linings, partitions, and ceilings requiring: high load-bearing capacity, enhanced acoustic insulation, suitability for medium-humidity areas, resistance to impacts and high foot traffic, and improved fire performance.

This EPD covers placa Pladur® OMNIA 13, with 13 mm thickness. A scaling table is provided in Annex for placa Pladur® OMNIA 15 with 15 mm thickness.

The product is manufactured in 2 plants. The result is averaged based on the production volumes

MANUFACTURING AND PACKAGING (A1-A3)

The environmental impacts considered for the product stage cover the manufacturing of raw materials used in the production as well as packaging materials and other ancillary materials. Also, fuels used by machines, and handling of waste formed in the production processes at the manufacturing facilities are included in this stage. The study also considers the material losses occurring during the manufacturing processes as well as losses during electricity transmission.

A market-based approach is used in modelling the electricity mix utilized in the factory, including the electricity produced from biogas and from photovoltaic sources.

Transport for raw materials considers the distance from the extraction or manufacturing location of the raw material to the production plant and the modelling of the relevant transportation type (e.g. road lorry, train, sea fret, ...) for each raw material.

Transport assumption has also been made to consider the impact of the transport of diesel and/or propane which are delivered by road lorries to the plant. Regarding the energy used: 1) propane is sourced locally from domestic production, 2) diesel is also sourced locally from domestic production using a mix of local oil fields and imported crude oil, 3) natural gas comes within a mix of local production and imports, 4) 100% of the electricity used in the manufacturing plants is sourced from renewable sources (solar, co generation using biogas from biomass).

Plant specific manufacturing waste data is reported by each manufacturing location into the Pladur internal information system. Manufacturing wastes are of the following types: 1) Plasterboard wastes generated on the production lines, reprocessed internally and used back in the process after treatment (no transport), 2) Paper wastes coming from paper rolls feeding the production line with front and back paper liner, reprocessed in the plant to specialize partners for treatment and recycling.

No process liquid water is released to the environment whereas water vapour is released in the atmosphere during calcination and drying. The transport assumptions for manufacturing wastes are based on the following principle: 1) transportation distances are calculated taking into account the address of the plant where the waste is issued and the address of the third party location where the waste is treated (Google map has been used to calculate the distance), 2) the transport method reflects the actual type of transport used to convey the wastes to third party location (i.e. road transport).

The product is delivered on bio-based flex spacers, using bio-based corner reinforcement and plastic straps.

The use of green energy in manufacturing is demonstrated through contractual instruments (GOs, RECs, etc.), and its use is ensured throughout the validity period of this EPD.

TRANSPORT AND INSTALLATION (A4-A5)

Transportation impacts occurred from final products delivery to construction site (A4) cover fuel direct exhaust emissions, environmental impacts of fuel production, as well as related infrastructure emissions.

Plasterboard products are delivered by road lorry from the manufacturing location to stockists and construction sites across Spain and Portugal. The average delivery distance considered in this study is 540 km, deducted from supply chain data analysis.

The two most common drywall installations for the Pladur boards are metal framing partitions and ceilings. A variety of building systems and components are used to deliver the required performances but are outside the scope of this declaration. However, the use of screw fixings, jointing material and paper tape is common to all applications and the consumption of these are declared within this section as installation resources. A small quantity of water is also consumed in the mixing of jointing materials. We have considered that no significant amount of energy is consumed during installation. Whereas a negligible amount of dust due to manual cutting can be released in situ (see the product technical safety datasheet for more information), we have considered that Installation does not produce any significant emissions.

5% Installation waste is considered. Installation wastes (plasterboard, packaging and installation resources) are transported by truck either to a

recycling facility (20%) over a distance of 250 km or to landfill (80%) over a distance of 50 km.

PRODUCT USE AND MAINTENANCE (B1-B7)

The product has a reference service life as stated above, providing the product is installed as per Pladur Gypsum recommendations. In such case, the product will last during its life of use without any requirements for maintenance, repair, replacement, or refurbishment throughout this period, providing normal and no accidental conditions of usage are encountered. The product will also not need any operational energy nor operational water to fulfil its duty, once installed in the building.

PRODUCT END OF LIFE (C1-C4, D)

At End of Life, the product is removed manually and transported by truck either to a recycling facility (20%) or to landfill (80%). No energy has been considered for C1 as it has been assumed that demolition is carried out without power tools or is using negligible amounts of energy. Module C2 is calculated using a distance of 250 km for recycling (20% of total quantity collected) or 50 km for landfilling (remaining 80%). We confirm the representativeness of this EOL scenario and that it is likely to occur.

Plasterboards, once recycled, provide gypsum in the form of powder which can be directly used in the process.

For the evaluation of the Loads and Benefits, we have considered the load of recycling of the installation wastes in A5 and the product at EOL (20% in mass) and the benefits of not using 20% of natural gypsum in A1. We have also considered the transfer of energy and biogenic CO₂ content to next product life.

MANUFACTURING PROCESS

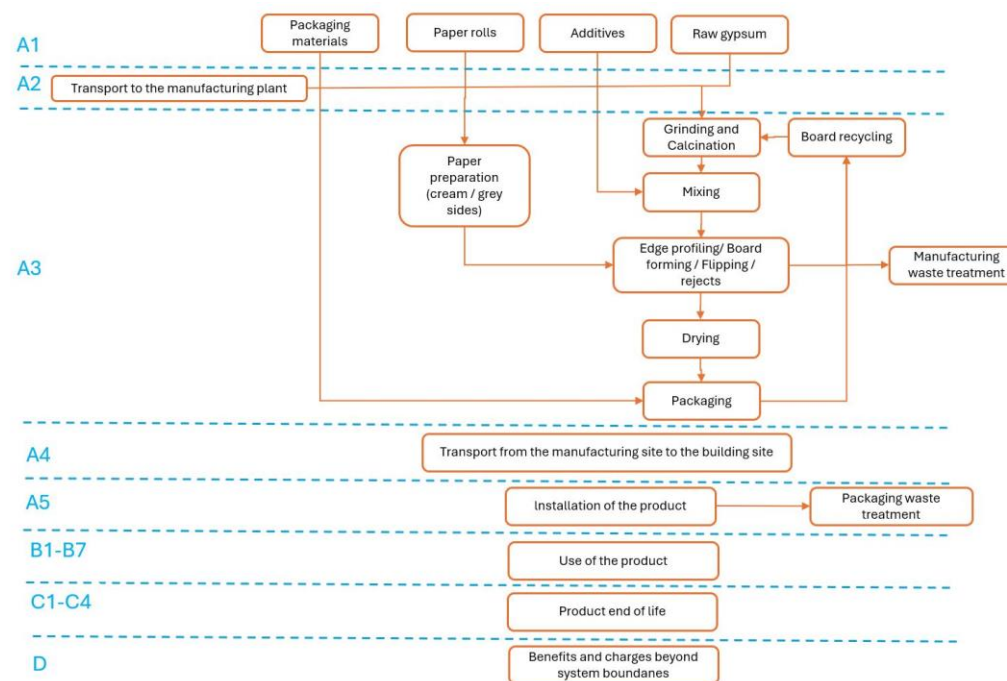
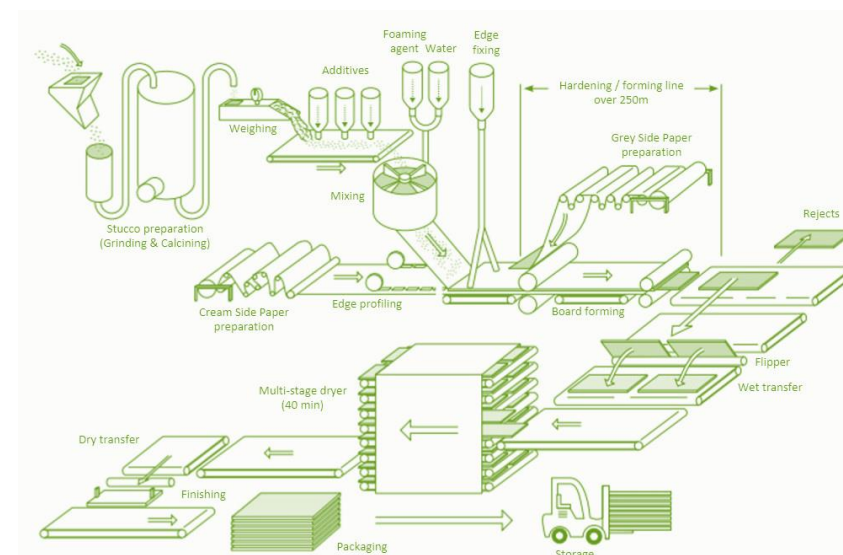
The gypsum mix is milled and calcined to plaster by heating to around 160 Celsius, then stored in silos. The plaster is then mixed with additives, wood fibres and water to form a slurry in which the rehydration back to gypsum begins. The slurry is injected between the face and back paper liners in a forming process which defines board thickness and width. During plaster setting over several minutes a high strength mechanical bond forms at the gypsum/ paper interface.

Excess water is removed from boards by passing them through a fan-assisted oven. During drying starch migrates to the surface of the gypsum core, adding further strength by means of a chemical bond. Dried boards are cut to size and then packed for storage and distribution.

Plasterboards are manufactured using state-of-the-art production equipment and following rigorous quality assurance standards, complying with EN ISO 9001:2015 and EN ISO 14001:2015, certified by third parties.

The product is manufactured on 2 production line in Valdemoro and Gelsa, Spain.



LIFE-CYCLE ASSESSMENT

CUT-OFF CRITERIA

The study does not exclude any modules or processes which are stated mandatory in the reference standard and the applied PCR. The study does not exclude any hazardous materials or substances. The study includes all major raw material and energy consumption. All inputs and outputs of the unit processes, for which data is available for, are included in the calculation. There is no neglected unit process more than 1% of total mass or energy flows. The module specific total neglected input and output flows also do not exceed 5% of energy usage or mass.

The production of capital equipment, construction activities, and infrastructure, maintenance and operation of capital equipment, personnel-related activities, energy and water use related to company management and sales activities are excluded.

The following processes are considered below cut-off:

- Packaging of raw materials, as the main raw materials (i.e. largest amounts), such as gypsum come in bulk.
- Ancillary materials for production other than lubricating oil
- Infrastructure and land use of the factory
- Environmental impacts caused by the personnel of the production plants are not included in the LCA, e.g. waste from the cafeteria and sanitary installations, accidental pollution caused by human mistakes, or environmental effects caused by commuter traffic.
- Heating or cooling of the plants in order to ensure a comfortable indoor climate for the personnel for example is also neglected.

VALIDATION OF DATA

Data collection for production, transport, and packaging was conducted using time and site-specific information, as defined in the general information section on page 1 and 2. Upstream process calculations rely on generic data as defined in the Bibliography section. Manufacturer-provided specific and

generic data were used for the product's manufacturing stage. The analysis was performed in One Click LCA EPD Generator, with the 'Cut-Off, EN 15804+A2' allocation method, and characterization factors according to EN 15804:2012+A2:2019/AC:2021 and JRC EF 3.1.

ALLOCATION, ESTIMATES AND ASSUMPTIONS

Allocation is required if some material, energy, and waste data cannot be measured separately for the product under investigation. All allocations are done as per the reference standards and the applied PCR. In this study, allocation has been done in the following ways:

This EPD covers the 12,5 mm thick Placa Pladur® OMNIA 13 produced in Gelsa and Valdemoro, Spain. The product is manufactured with 1200 mm of panel width. LCA calculations have been carried out for the product on each specific production line (single product , multiple factories), the results have then been averaged based on production volume and the variation in GWP A1-A3 has been calculated (<5,5%)

A scaling table is provided in Annex for Placa Pladur® OMNIA 15 also produced in Gelsa and Valdemoro, Spain.

This EPD is product and factory specific.

LCA SOFTWARE AND BIBLIOGRAPHY

This EPD has been created using One Click LCA EPD Generator. The LCA and EPD have been prepared according to the reference standards and ISO 14040/14044. The EPD Generator uses Ecoinvent v3.10.1 and One Click LCA databases as sources of environmental data. Allocation used in Ecoinvent 3.10.1 environmental data sources follow the methodology 'allocation, Cut-off, EN 15804+A2'.
